







Relative Intensity Vs. Wavelength






- 1.Protective current—limiting resistors may be necessary to operate the Displays.

Reflow Soldering Profile For Lead-free SMT Process.




- OILS: 1.We recommend the reflow temperature 245°C(+/-5°C). The maximum soldering temperature should be limited to 260°C.

 3.Number of reflow process shall be 2 times or less.


